## HREC Arranges Sale of DoubleTree Hotel Williamsburg, Virginia

Williamsburg is the epicenter of Virginia's Historic Triangle, an area steeped in American history. In addition to proximity to an abundance of historic landmarks, the Hotel is adjacent to Busch Gardens, one of the most visited theme parks in the country. The Hotel is also located near 14 golf courses, Williamsburg's Premium Outlets, the Virginia Air and Space Museum and Water Town USA. The Hotel is within four miles of the College of William & Mary, 0.5 miles from Anheuser Busch's Williamsburg Budweiser brewery, and 5 miles from the Yorktown Naval Weapons Station (a U.S. Navy base that provides weapons and ammunition storage for the ships of the U.S Atlantic Fleet). Additionally, there are several major corporate demand generators near the Doubletree, including Ball Metal, Tempus Jets, Pepsi Bottling Group, and National Center for State Courts.
