We expect there to be significant loan sale activity this year due to ongoing softness in hotel demand as a result of the pandemic. Although we expect hotels to achieve a robust recovery in the coming years, there will be hotels that struggle in the near-term forcing lenders to consider note sales and foreclosures”, commented Greg Porter, Senior Vice President.
