Peachtree Hotel Group has acquired the property. Peachtree Hotel Group operates, develops and invests in premium-branded, select- and limited-service and extended-stay hotel assets under the Marriott, Hilton, Hyatt, Choice and InterContinental Hotels Group flags. Peachtree's current portfolio is comprised of 95 hotel assets totaling 11,849 rooms, including 39 real estate assets and 56 notes.

The Price road corridor is also home to one of 4 GM regional technology offices employing over 1,000 people, as well as financial services companies anchored by Wells Fargo with over 5,000 employees. The property is located next door to Chandler Fashion Center Mall, which provides walkability to high end retail stores as well as numerous dining and entertainment establishments. The TownPlace Suites location at the 101/202 freeways provides easy access to the entire valley as well.
